**PROTECTIVE EQUESTRIAN HEADGEAR REFUSAL AGREEMENT**

I, for myself and/or on behalf of my child or legal ward, have been fully warned and advised by The Foothills Indian Horse Club (hereinafter referred to as FIHC), that we should purchase and/or wear a properly fitted and secured ASTM/SEI Equestrian Standard certified helmet while riding or being around horses (whether on the premises of FIHC or off the premises) in order to reduce the severity of some of our head injuries and to possibly prevent my/our death from happening as a result of a fall(s) or any other occurrence possibly associated with this activity. We realize that we are subject to injury from this activity and that no form of preplanning can remove all of the danger to which we are exposing ourselves. Against the advice of the FIHC, we are refusing this critical safety precaution.
